CHAPTER V

CONCLUSION AND SUGGESTION

5.1 Conclusion

Derived from the result that has been obtained and analysed. The Research was to identify the types of deixis used in novel Catharsis by Anastasia Aemilia:

- 1. The types of deixis that is used in the novel Catharsis by Anastasia

 Aemilia were:
- a. Person deixis: I, you, your, me, she, he, him, her, they, we, us, them, our, their, my, Doctor, honey, sweetheart and darling,
- b. Spatial deixis: Now, later, this, few minutes, next week, the night, other day, that night, earlier in the evening, long time ago, etc,
- c. Temporal deixis: Here, there, this room, going to, this, nowhere, my room, my house, etc.
- 2. The reference of types deixis that used in the novel Catharsis by Anastasia Aemilia were:
- a. Person deixis: Tara, Alfons, Bara, Tari, Arif, Sasi, Ello, Heru, Jerry, Irene, Johandi family, officers, Martin, Andita, Moses, etc,
- b. Spatial deixis: The place of picture Martin and Andita, Tara's room, Ello's hand, Arif's position, Surrounding environment, Moses's house, Tara's school, Bandung, Alfons place, Wooden chest, Jakarta, Beside of Ello, In front of Ello's house, Hospital, Outside of Police station, Letter in Tara's hand, Police station, hotel for Tara, the wooden-chats of Alfons, etc.

1. For Students


The students of pragmatics may use this study as a reference to understand the relevance of pragmatics and how it is applied in the daily life especially about deixis expression.
